AWARD WINNERS

A sold-out event comprised of business leaders and community members of the Cumberland Valley Business Alliance (CVBA) gathered in March to honor individuals and organizations for their outstanding achievements at the CVBA Awards Breakfast, sponsored by **M&T Bank**.

ATHENA Leadership Award: Dr. Lura Hanks of Greencastle-Antrim School District was honored for this award that is sponsored locally by **Jennings Chevrolet, Buick, GMC and F&M Trust**. Dr. Hanks has dedicated herself to enhancing education in Greencastle, focusing on curriculum development, literacy improvement, inclusive teaching methods and fostering collaboration among community stakeholders.

Spirit of the Community: Sam Worley was recognized for his tireless and unselfish commitment to improving the quality of life in the Cumberland Valley. Sam is a World War II veteran and worked many years at the Valley Bank, served as a County Commissioner, Fourth Ward representative on Chambersburg Borough Council and was Mayor.

Innovator of the Year: Matthew Wedd of The Conococheague Institute was honored for his pioneering practices. In 2023, he increased the site's endowment from \$40,000 to \$945,000. The site now sees approx. 6,000 students per year, with many bringing back family members for programming.

2023 Event of the Year: The Fort Loudoun Market Fair, hosted by the Fort Loudoun Historical Society, transforms the fort into a village with 50 of the best 18th century artisan craftspeople for an encampment, music, food and entertainment. Last year, 5,000 people attended.

Nonprofit of the Year: Children's Advocacy Center of Franklin County was recognized for its innovations and community collaboration. Their mission is to provide a safe, child-friendly location and atmosphere for children and their families to receive services that help to restore hope and provide healing from child abuse.

Employer of the Year: Russell Standard received this award for its culture of care, providing work/life balance and opportunities for personal and career growth. They offer a zero-premium healthcare plan, pet insurance, legal insurance, increased paid time off, increased work travel pay and more.



Emerging Business Leader: Kacie Gelsinger was recognized for her pursuit of career excellence while also making valuable community contributions. Kacie is part of **The Floor Trader Outlet of Chambersburg** with her family and is an active member of the Franklin Co. Therapeutic Riding Center, Franklin Co. Builders Association and Chambersburg Chamber Board.

Bravery in Blue Award: James Flannery, Deputy Sheriff, K9 Deputy was honored for his bravery as he is on call 24/7 with the potential of responding to bomb threats up to three counties away; he also has daily assignments as a field division deputy. Every morning James and his K9 conduct perimeter and interior sweeps of buildings to search for any threats.

Courageous Responder Award: Elizabeth Heller, Paramedic & Assistant EMS Chief at **Fayetteville Volunteer Fire Department**, has devoted her life to community EMS, going beyond her duties to implement prevention programs like car seat safety, expanded safety checks and CPR education. Her efforts have empowered community members to save lives and her initiatives promise a lasting impact on the community.

Cumberland Valley School of Music (CVSM) is a nonprofit organization providing high-quality, diverse musical instruction and related artistic experiences that have enriched the creative lives of our community since 1990. An average of 750 participants each semester - *newborn through seasoned citizens* - are served by CVSM with instruction provided in music, drama and more through individual and group lessons, camps, workshops, ensembles and classes. Live performance opportunities are provided through events such as recitals, concerts and the annual Performathon. Additionally, the school sponsors scholarship programs to ensure instruction is accessible to all.

CVSM strongly believes that the benefits of the study of music and participation in musical activities extend beyond musical proficiency to academic and vocational performance, social skills development and enhancement, and life experience enrichment. Current pARTnerships include **The Boys and Girls Club of Chambersburg and Shippensburg** (children's choir), **Network Ministries** (piano, drum & guitar lessons), **First Start Partnerships for Children and Families** (Arts Integrated Preschool in 14 classrooms), Pathstone Child and Development Center



(preschool and toddler music classes), Global Vision Christian School (music lessons) and House of Grace (music activities).

CVSM has two locations and three satellites. The Chambersburg location (on the **Wilson College** campus) has 16 teaching studios and a public music store. The Greencastle location (on the square) has seven teaching studios and a public music store. The satellites are in Waynesboro, Mercersburg and Hagerstown. Mama K's Buns is a from-scratch bakery in Greencastle, PA owned and operated by Terry & Kris Yoder. Our bakery started in our home in May 2019 with our flagship item - cinnamon rolls (or cinnamon buns as we call them) and a few other items like cookies, cupcakes, pies and dinner rolls. We sold our baked goods at Greencastle's 3rd Saturday in the Square from 2019-2022 and out of our home by order only for holidays and special requests.

Soon enough, the bakery was starting to take over our home! We created a fundraiser program with our cinnamon buns during that first year, and because of its overwhelming success, it became apparent we needed to move this bakery side gig out of our house and into commercial retail space. That's how we landed our current location in Greencastle.

We offer six variations of our cinnamon buns, pies, cookies, cupcakes and breads on a weekly basis and have made over 93,000 cinnamon buns in our building since August 2022! Our storefront is open Thursday and Friday from 7 a.m. - 5 p.m. and Saturday from 8 a.m. - 1 p.m.

Our cinnamon bun fundraiser program continues to thrive and grow, with many organizations who fundraise with us being kids sports teams and/or activities. We bake buns for at least one fundraiser organization every week and are usually booked full for several months out.



Another fundraiser event we do once a month is "Soft Pretzel Saturday". This is the only day we make soft pretzels in the bakery and it's always to either help a family in our community with a special need or occasionally to support a sports team. Nonprofit hospitals are exempt from paying most federal, state and local taxes in exchange for providing free or discounted care and programs that address community health needs – things like substance use treatment, food, transportation and mobile clinics. A new report from the Lown Institute, an independent healthcare think tank, finds that **Meritus Health** Medical Center spent more on financial assistance and community investment than the estimated value of its tax exemption in 2021, giving the hospital what the Institute calls a “fair share” surplus. Meritus Medical Center is among only 20 percent of nonprofit hospitals nationwide to have such a surplus, and in the top 1.5 percent for the amount of additional spending for community benefit.


